About Social Action for Health

We are a community-based charity providing services and support to people most affected by health inequalities in Tower Hamlets and its surrounding boroughs.

Social Action for Health's roots trace back to the 1986 Tower Hamlets Health Campaign. A coalition of local healthcare workers, GPs, academics, and social action activists came together to address cuts to the health system and barriers to accessing health services. Their work resulted in the completion of the Tower Hamlets Health Inquiry, which highlighted the significant impact of poverty, unemployment, and poor housing on the Tower Hamlets population, as well as the multiple barriers facing minoritised ethnic communities in accessing basic goods and services.

Our vision is for a world where unfair and avoidable health inequalities no longer exist, and we believe that the more control people have over their lives, the better their health and wellbeing.

We provide services and support (find out more here) within local communities to:

- Increase people's ability to identify personal priorities and goals
- Increase people's confidence to make decisions about their health and wellbeing
- · Increase people's ability to act on their decisions

The Trustee Role

Our board of trustees provide overarching governance and clear strategic direction, alongside supporting our small staff team on several areas, including fundraising and impact evaluation. We are a hands-on board, and each trustee is involved in one or more work streams, donating their skills and knowledge to support the CEO and her team.

The range of core responsibilities includes:

- Reviewing our strategy and operations, making sure they're able to deliver our vision
- Ensuring we use our resources prudently and effectively, and making sure we have appropriate financial controls in place
- Complying with all relevant legislation, including the Charities Act 2006
- Acting in the best interests of the charity, avoiding actual and/or potential conflicts of interest

 we do it
